Jurisprudence Committee recommends Increase in Lodge dues and assessments!

The Committee on Jurisprudence of Blazing Star Lodge No. 26 met on the afternoon of May 9, 1998 at the Loge Gebouw of Jacob van Campen Lodge in Amersfoort, the Netherlands. The By-Laws of Blazing Star Lodge were critically analyzed to see if they continue to conform to the Constitution and By-Laws of the MWPH Grand Lodge of Massachusetts. Discussion was held on the need to modify certain Sections of the By-Laws to make them more applicable to the present situation of Blazing Star Lodge No. 26.

The proposed changes to the By-Laws of Blazing Star Lodge No. 26 are as follows: Present

Section 6: A member whose name has been dropped from the rolls of the Lodge for non-payment of dues may be restored only upon written application, reinvestigation, the payment of a sum of money equivalent to one year's dues, taxes and assessments, the payment of reinstatement fee of \$25.00, the advance payment of Lodge dues and assessments for the ensuing twelve (12) month period commencing on the month of restoration, and by a unanimous vote of acceptance of the members present at the communication at which the application for restoration is acted upon.

Proposed change: Change reinstatement fee to \$35.00.

Section 34: Once the applicant is favourably balloted upon, the Secretary shall inform the applicant and provide him the appointed time and place for initiation.

Present:

Section 37: Each member of this Lodge shall pay into the treasury the sum of \$2.00 per month as dues.

Proposed change: Increase the dues sufficiently to cover our Lodge rent and other fixed costs of the Lodge each year. Change \$2.00 per month to \$8.50 per month. The total amount of dues, District Fund, and Grand Lodge Taxes will be \$142.00 per year.

Section 37: Each member of this Lodge shall pay into the treasury the sum of \$8.50 per month as dues.

Blazing Star Lodge #26 has done well since the closing of Camp New Amsterdam. We have had a lot of support from Volkel and NATO. Depending on these sources causes us to be very dependent on the political decisions of the US Government. We must try to grow within the Dutch community. In order to do this and to continue our tradition of charitable giving we need a solid financial base. We cannot have this if the proceeds from all of our fund-raising activities are used for rent, Grand Lodge fees, etc. If the dues that we collect each year pay all of our fixed fees we can utilize our fund-raising activities to help the community and encourage Dutch membership.
